Rig Health, Safety, and Environment (HSE) Specialist

Rig-HSE Specialists are initiative-taking individuals responsible for assisting the Drilling Operations and Logistics Services teams in implementing, monitoring, and reporting CGX's Environmental Assessment Management Plan (EAMP) tasks and activities. Rig-HSE Specialist is stationed on the Maersk Discoverer Mobile Offshore Drilling Unit (MODU) for the WEI-1 Campaign in Guyana, with limited onshore work commitments.

The primary responsibility of the Rig-HSE Specialist is to ensure that Rig personnel (rotators) are trained on the Guyana EPA Operations Permit compliance, Good Environmental Practices, and CGX's HSE Plan requirements, including but not limited to:

- ✓ Leading CGX's team engagement in Preventative Safety Observation (PSO), OHS Audits, Incident investigation, and Operational Risk Assessment reporting.
- ✓ Ensuring that all incidents, including near misses and environmental releases, are reported and investigated in compliance with CGX standards.
- ✓ Acting as CGX's waste management plan coordinator on the Rig to ensure chain of custody documentation between the drilling contractor, production support vessels, and onshore waste treatment facilities.
- ✓ Being the coordinator of the Guyana EPA remote inspection program; Deck/Pipe Deck, Rig Floor, Driller's Shack, Pits, Shakers, Mud Pumps, Accumulator, Safe Welding Area, Bridge / Living Quarters.
- ✓ Attendance at all offshore HSE meetings, including weekly Rig department safety meetings, pre-tower meetings, and daily toolbox meetings.
- ✓ Assisting in developing HSE standards, procedures, and safe work practice documents.
- ✓ Accompanying third-party auditors or EPA inspectors on CGX-operated or leased facilities, rigs, or production support vessels to facilitate safe access and report non-conformances.
- ✓ Providing technical report writing for EPA Operations Permit Monthly Reports and JV HSE Committee monthly reports.
- ✓ Executing daily, weekly, and monthly CGX Rig-HSE duties.

Job Requirements

- ✓ Offshore Guyana exploration drilling HSE Experience dealing with multiple contractors.
- ✓ Proven ability to work independently and within a multidisciplinary team environment.
- ✓ International Marine Dangerous Goods (IMDG) Code packaging and transportation certificate.
- ✓ Certified Safety Professional (CSP) or equivalent NEBOSH certifications.
- ✓ Maritime Personnel H2S Detection and Exposure Training (US OSHA).
- ✓ HSE technical expertise, one-to-one coaching, and individual or group training delivery.
