The Government of Guyana (GoG) is seeking the safe and timely development of its gas resources as well as creating an open-access infrastructure system for all existing and future Upstream participants to support current and future Upstream developments in Guyana. "Upstream" means the upstream oil and gas developments including the necessary pipelines to connect, as needed, to such gas infrastructure required to monetize upstream gas. Applicants shall evaluate the commercial, technical, and environmental feasibility for the necessary infrastructure ("the Project").
- 2. The Government of Guyana through the Ministry of Natural Resources (MNR) hereinafter referred to as "the Procuring Entity", invites interested Applicants to submit Proposals for the project: Design, Finance, Construction, and Operation of required Gas Infrastructure to Support Upstream Developments. In order to be considered, all interested parties must respond to this RFP.
- 3. This project will be strictly financed and owned 100% by the private sector. As part of this RFP process, the selected Applicant, if any, with the most optimum solution for the Project, will have exclusivity to negotiate with the GoG for its entitlement of gas to ensure the viability of the Project and the overall value chain.
