Request for Proposals (RFP) - Engineering Services for Storage and Offloading of NGLs

The Government of Guyana (GoG) invites firms to participate in a Request for Proposals (RFP) for **Engineering Services** in development of a Natural Gas Liquids (NGLs) Storage and Offloading Facility and pipeline as part of the Gas-to-Energy (GtE) project. This Facility is required by the GoG to enhance the capacity for safe storage, efficient operation, and effective distribution and marketing of NGLs, both domestically and internationally.

The Government of Guyana (GoG) and Guyana Power and Gas Inc. (GPGI) invites Requests for Proposals for the Engineering firms to prepare a **detailed RFP to be issued to pre-qualified firms** to construct both an NGL Pipeline and a Storage and Offloading facility

The NGL Storage and Offloading project will be located within the Wales Industrial Zone approximately 25 km inland from the mouth of the Demerara River on the West bank adjacent to the Phase I Power Plant currently under construction. The Gas-to-Energy (GTE) Phase I project includes a Natural Gas Liquid (NGL) fractionation plant to extract liquids (C3, C4, C5+) and provides limited storage.

Engineering services are needed to develop a comprehensive RFP package and updated Employers' Requirements (ER) document needed to bid and fully develop a facility able to receive and store sufficient volume of NGLs to allow for no disruption in the Phase I plant and to optimize batch offloading to marine vessels. The production rate from Phase I is anticipated to be approximately 4,200 bbls per day of NGLs. The design should be sufficiently flexible to accommodate, with modifications, additional future NGLs anticipated from a Phase II power plant delivering up to 5,900 bbls per day. Firms will be expected to complete the RFP package in approximately **two (2) months** from start of contract.

Only firms (consortia) adjudged to be experienced in Engineering Services of comparable facilities, will be evaluated. Firms will need to have a global presence and have a strong HSSE design culture and able to demonstrate excellent project management support and reporting of Engineering and Construction with financial capacity to manage large-scale projects.

Responses to this RFP must include:

- i. A fully detailed cost proposal including the following elements: (a) Comprehensive cost schedule for each labor type/position (b) cost method for per-diem, travel or other expenses with examples (c) detailed list of fees/markups (d) Expected profit margins; and
- ii. Identify any costs anticipated that will not be covered by the contract; and
- iii. List of relevant experience and reference projects, past and current, with similar operations over the last 15 years, however, Proposals from firms that have successfully completed at least ten (10) such facilities in the last ten (10) years will be given preferential status; and
- iv. Provide a template of a contract from an ongoing or similar project; and

- v. Submit organizational chart (separating local vs foreign staff) and ramp-up assuming start of services September 20, 2025; and
- vi. Provide resumes/CVs for all proposed lead positions; and
- vii. Projected project schedule showing key milestones to meet anticipated plant design.
- viii. Provide any disclosures of any potential conflicts of interest; and
- ix. Audited financial statements or other evidence of financial strength; and
- x. Local content approach including projected workforce during design, value of local purchases of goods and services.

The RFP shall incorporate all the above and additional details. The GOG may convene discussions during the RFP period for registered parties to gain additional clarification on key terms or proposals. Interested parties should submit all questions by email as early as possible to allow for sufficient time to address within the RFP period but not later than July 7, 2025.

Interested companies shall bear all costs associated with their response to this Request for Proposals (RFP). Interested parties must register, pay a fee of G\$25,000, and obtain an RFP document by contacting the PS-OPM below. Additional details can also be obtained from the email below.
